#### Mission

WEI advances human rights at the intersection of gender and disability to respond to: the lived experiences of women and girls with disabilities; promote inclusion and participation; and achieve transformational equality.

#### Vision

WEI envisions a world where women and girls with disabilities claim human rights, act in solidarity, and lead self-determined lives.

### Partnering In Advocacy

WEI's legal advocacy strategies rely on continuous collaboration with partners — from data collection and documentation of rights violations, to engaging with international human rights mechanisms to secure recommendations that respond to the lived experiences of women and gender minorities with disabilities, to pushing governments to implement changes that uphold rights and improve lives.



One example of this in 2021 was WEI's submission to the UN Special Rapporteur on the right to health, which drew on research conducted in partnership with 7 women-led organizations.

Our research asked 300 women and gender non-conforming persons with disabilities around the world about how the COVID-19 pandemic impacted their lives. Sharing our findings, we advocated to address gaps identified in the global response to COVID-19 and to strengthen responses to future crises.

Another example of WEI's collective advocacy was our joint submission with 6 partner organizations to the UN Committee on the Elimination of Discrimination Against Women about the barriers faced by indigenous women and gender minorities with disabilities to fulfill their human rights.

# 360° Capacity Strengthening



WEI's 360° capacity strengthening approach means that we strive to bolster the capacity of women and gender minorities with disabilities themselves and, as importantly, to provide mainstream movements, governments, UN agencies, and other stakeholders with guidance to promote meaningful inclusion of — and responsiveness to — those living at the intersection of gender and disability.

In just one of our many capacity strengthening projects in 2021, WEI partnered with UN Population Fund (UNFPA) Regional Office for Eastern Europe and Central Asia, which serves nearly 20 countries, on a series of webinars addressing issues related to GBV.

The webinars convened more than 85 participants from multiple sectors — including UNFPA staff, government officials, regional program administrators, and direct service providers. WEI utilized a curriculum developed by UNFPA and the East European Institute for Reproductive Health — with technical support from WEI — to impart tools and best practices on how to tailor preventive and support services to the rights and needs of persons with disabilities survivors of violence.

### **Cross-Movement Building**

WEI increasingly plays a 'scaffolding' role to strengthen the disabled feminist movement and to create conditions that increase inclusion and leadership of disabled feminists across the gender equality and disability justice movements - and beyond. For example, in 2021 WEI provided logistical and communications assistance to support the development of a Latin American collective that grew out of an earlier regional convening we held in Costa Rica. We also conducted outreach and consultations with women, nonbinary persons, and gender minorities with disabilities in the U.S. to lay the groundwork for organizing a new cross-disability national alliance.

On the global level, WEI was selected as a civil society leader of the Generation Equality Forum — one of the only organizations working at the intersection of gender and disability in this critical space. We served on the Feminist Movements and Leadership Action Coalition and spearheaded outreach to organize and energize an Inclusive Generation Equality Collective to foster greater participation by disabled feminists in the overall GEF process and agenda, as well as to hold stakeholders accountable for their GEF commitments aimed at achieving irreversible progress towards gender equality over the next five years.

#### Strategic Communications




